Division Updates

- Division update Greg stated the Division is now the National Fire Academy and North American Fire Training Directors point of contact for Missouri. The Division is working through the logistics of this process and will keep the Commission informed as we move forward.
- Budget updates The Division submitted a budget request package to the Director's office and is awaiting the Governor's recommendations.
- Legislative updates Bills were pre-filed starting Dec. 1. Bills filed so far involve the inspection of nursing facilities, LODD benefits for our staff, tax credit for fire fighters obtaining annual training, expert witness requirements, grants for volunteer fire departments for workers comp, and a long-term care licensing bill.
- Staff updates The Training Unit has a new Training Technician II, John Loveless. John has law enforcement and fire fighter training in his background and we are excited about having him join our team. The Division also hired two new investigators: one in Hillsboro and one in Nevada. We have an open position for an Elevator Inspector in the St. Louis area.

- Training Program Update Kim stated the IFSAC re-accreditation visit will start on December 3rd with representatives from Kansas, Kentucky and Arizona. Also joining the team would be an observer from Illinois. We are expecting a positive outcome from the visit.
- As part of the re-accreditation visit, the Division Training staff is presenting 16 new levels for review. This would bring the Division total accredited certification levels to 30.
- A plan for the rollout of the new levels will be presented at the next commission meeting.
- The Training Unit also recently completed the first update for the revised Driver Operator course and certification program with 24 students who will be the new instructors of the program. Two classes are being done now.
